Sealed Bids for the construction of the CCTV Sanitary Sewer Inspection Project will be received by Wheatland Township at the office of the P.O. Box 229, Remus, MI 49340 until 10:00 am local time on Monday, April 15, 2019 at which time the Bids received will be publicly opened and read. The Project consists of; video inspection of approximately 200 linear feet of 6" sewer, 10,000 linear feet of 8" sewer, 4,000 linear feet of 10" sewer and related work.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00am – 5:00pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents are available at no charge through Microsoft OneDrive, or on compact disc (as portable document format (PDF) files) for a non-refundable charge of \$20.00 (twenty dollars), including shipping via overnight express service. Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$100.00 (one hundred dollars) per set, payable to "Gosling Czubak Engineering Sciences, Inc.", plus a non-refundable shipping charge. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.
