

ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **City of East Jordan Wastewater Treatment Plant** will be received at the office of the **City of East Jordan, 201 E. Main Street, PO Box 499, East Jordan, MI, 49727-0499**, until **11:00 a.m.** local time on **June 9, 2017**, at which time the Bids received will be **publicly** opened and read. The Project consists of the construction of a **0.239 MGD extended aeration mechanical plant, including: headworks building; reactor basins and aeration equipment; clarifiers; transforming existing aeration lagoons to biosolids handling and storage; rapid infiltration basins; lab building; and all associated piping and valves.**

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.
